




How optimistic or pessimistic do you feel about the **UK economy** over the coming 12 months?

Mean scores (where 0 represents 'very pessimistic', 50 'neutral' and 100 'very optimistic')




Optimism/Pessimism toward business prospects

Expectations regarding job growth: Mean expected employment change over the next 12 months










Expectations regarding turnover: Mean expected turnover change over the next 12 months





What would be your preferred way of raising capital, if the need arose in the next 12 months?








Ease of raising capital for small and mid-caps








Directors & Officers liability insurance: premium rate



'All D&O premiums seem to have gone up significantly in the last 12 months' 'Believe it is likely to become more expensive as risks for directors increasing all the time due to regulatory changes and cyber risk'

'I understand that D&O insurance premiums have skyrocketed recently. This is a very worrying development.'

'Know that rates have gone up and cover is constrained'

'Premiums have soared due to anticipated risk of company failures when the pandemic safety net ends. We tested 8 companies and 6 would not quote'


'We experienced a 60% increase in premiums'

'Large increase in premium, now reduced cover by half'

'Cost is rising significantly'




COVID-19 and the return to the workplace




What is your organisation's plan with regards to having staff in the workplace when lockdown is next over? We plan to...






In the future, will your organisation be more flexible than it was pre-pandemic with regards to employees working from home/remotely?






Will you encourage staff to return to the workplace?

In the future, how do you think the average employee at your organisation will split their working time between the office and home?





Chart displays mean split




In the future, is your organisation more likely to allow flexible working hours?






Are you updating staff contracts as a result of changed working patterns (e.g. with regards to remote working, flexible hours etc)?






If working remotely and/or flexibly are to become more common, have you considered how this may impact diversity and inclusion throughout your organisation?






Have you held any of these events/meetings online, rather than face-to-face in the past year since the first lockdown began?
