Enhancing transparency of beneficial information of foreign companies undertaking certain economic activities in the UK

## Introduction

We are the Quoted Companies Alliance, the independent membership organisation that champions the interests of small to mid-size quoted companies. Their individual market capitalisations tend to be below £500m.

The Quoted Companies Alliance is a founder member of European**Issuers**, which represents over 9,000 quoted companies in fourteen European countries.

The Quoted Companies Alliance Corporate Governance Expert Group has examined your proposals and advised on this response. A list of members of the Expert Group is at Appendix A.

## Response

We welcome the opportunity to respond to this consultation paper.

We note that there will be a review of the register of persons with significant control (PSC Register) regime in 2019; subsequently, we believe that it is important to assess how UK companies adjust to this incoming PSC Register over the next two years before suggesting further measures to include foreign companies.

Furthermore, we believe that the Disclosure and Transparency Rules, Chapter 5 (DTR 5) exemption used in the incoming PSC regime should be replicated in any property and procurement regime so that the only requirement needed for a company is to identify being, or being a subsidiary undertaking of, a DTR 5 issuer.
